All Tenders must be accompanied by a Tender Security (Bid Bond) in an amount of **JD 16,000** (**twenty five thousand Jordan Dinar**) in the form of a Bank Guarantee issued directly by an approved Bank located in Jordan, in the form provided in the Tender Documents.

As per Jordanian regulations, the contractor must have a license from the Energy and Minerals Regulatory Commission (EMRC) for supply, installation, testing, commissioning and maintenance of Photovoltaic systems, class A or B. The submission of such license might be done after the awarding stage. Failure to provide it will lead to the rejection of the offer and to move to the next highest evaluated bidder in the tender evaluation.

In order for an entity to be eligible for a renewable energy license by EMRC, the entity shall be classified under the Government Tenders Department (GTD) as Grade (1 or 2) in the field of Electro Mechanical, specialized in the Electro Mechanical and renewable energy or be a renewable energy company that is entering into a consortium with a local contractor classified under the GDT as Grade (1 or 2) in the field of Electro Mechanical, specialized in the Electro Mechanical and renewable energy. In this second case (that is, if the awarded company is not itself classified under the GDT as Grade 1 or 2, in the field mentioned above), and only for the purposes of this project: (i) forming a consortium with a local contractor will not be compulsory and it will be sufficient to subcontract a local contractor who has a GDT certificate, as described above and (ii) the percentage of local participation is to be determined by the awarded bidder in a private agreement with the local subcontractor.
